

Advanced Governmental Tax Program - Assisting Tax Authorities to improve tax revenue performance

AGTP is a new initiative for tax reform in developing countries. AGTP connects the traditional way of advising on tax policy and administration with a sociological approach to taxation, putting strong effort on building support and acceptance in the tax community and society as a whole for developing and implementing of a robust and sustainable tax system.

PRINCIPLES

AGTP key principles for designing solid tax systems include:

- Simplifying of legislation to promote compliance
- Broadening of tax bases by reducing exemptions, thresholds, reduced rates, tax holidays and special regimes to a minimum, enabling low general rates
- Balancing the tax mix of taxes on income, profit and capital and taxes on consumption
- Modernizing of customs procedures
- Designing legislation that is feasible, practical and easy to administer





AGTP experts are highly experienced in drafting of tax and customs legislation with a strong focus on consistency of the tax legislation and on feasibility and practicality of its implementation, and on reducing of compliance costs for taxpayers.

Effective taxation requires compliant taxpayers.

Compliance behaviors of taxpayers highly depend on perceptions taxpayers have about the fairness of the tax system and its administration, including perceptions about:

- The complexity of the tax laws
- The ability of the tax authority to provide the appropriate mix of compliance and service activities
- The way tax policy makers and administrators engage with stakeholders to improve the processes of tax legislation and administration, and
- The competence, professionalism and attitude of staff

AGTP experts provide advice to Tax Authorities to improve the effectiveness and efficiency of tax and customs administrations. Key elements include:

- Developing and implementing of an integrated chain approach to manage tax administration processes including taxpayer identification and registration, return filing and assessment, audit and verification, appeals handling and enforced tax collection
- Understanding and influencing of taxpayers compliance behavior
- Segmenting of taxpayers according to their economic and revenue importance and to their services needs and compliance behaviors
- Providing taxpayer services according to the needs of the taxpayers using state of the art technologies and communication channels
- Developing and implementing risk based compliance interventions
- Measuring of outcomes and performance
